FIRST ORDER OF BUSINESS

Roll Call and Pledge

Chairman Lawens called the meeting to order and led the Pledge.

SECOND ORDER OF BUSINESS

Upcoming Meetings and Events

ON MOTION by Leon Van, seconded by Brian Acker with all in favor the regular meeting was adjourned to conduct the Public Hearing on FY 2013 Budget and Water Rates and Fees.

THIRD ORDER OF BUSINESS

Public Hearing

The public hearing was called to order and there were no comments from the public.

The District received a quote from Long's A/C in the amount of \$24,175 for a generator for the maintenance shop, and from Bassett Electronics in the amount of \$24,905 for the installation of a security system at the District Office, the Community Center, and Pine Breeze Park. Discussion was held regarding amending the current Fiscal Year 2012 budget utilizing capital project reserves and removing these two projects from the Fiscal Year 2013 budget.

Bill Lawens addressed increasing legal fees. After discussion it was decided to leave legal fees at the current level and adjust if the need arises.

Brian Acker asked questions on the personnel budget increases for parks. Joe DeCerbo made a presentation to the Board on the Professional Development Strategy and how job functions were created to identify what staff does and how the salaries are put in place. Job functions are continually being evaluated. Budget and reporting forms will be revised for Fiscal Year 2013 in an effort to develop more clarity.

The Board received copies of a white paper from Florida Rural Water Association on seasonal rates and no changes will be made to the Districts policy regarding minimum billing. The water rates will remain the same for Fiscal Year 2013.

ON MOTION by Brian Acker, seconded by Gary Behrendt with all in favor the public hearing was closed and the regular meeting reconvened.

FOURTH ORDER OF BUSINESS

Request approval of Minutes

The Board received copies of the minutes from July 11, 2012 for review. There being no further questions.

ON MOTION by Leon Van, seconded by Gary Behrendt with all in favor the July 11, 2012 Minutes were approved.

FIFTH ORDER OF BUSINESS

Request approval of Financials

The Board received copies of the July financials for review. There being no further questions.

ON MOTION by Brian Acker, seconded by Leon Van with all in favor the July 2012 Financials were approved.

SIXTH ORDER OF BUSINESS

Attorney

A. Ming Property

Bill Nielander spoke to Mr. Ming's attorney and he is not willing to trade access roads but is willing to trade property. Brian Acker stated he was in favor of improving the shell road but not the fencing. The Board does not want to trade property and will just maintain the current road.

B. Lands along the Levee

Ms. Francis informed Mr. Nielander that she will be getting an appraisal and will send it to him upon completion.

C. Maguire Trust

Should have a formal proposal for the Board at the September meeting.

D. Golf Ball Retrieval Policy

Bill Nielander and Leon Van created a draft golf ball retrieval policy. Board directed staff to create a resolution to present to the Board for approval at the September meeting.

E. Manager's Evaluation

Bill Nielander reported that all of the Board members had completed their evaluations of the District Manager and copies of the evaluations will be placed into the District Manager's personnel file. There was no other discussion.

SEVENTH ORDER OF BUSINESS

Treasurer's Report

A. Assessment Deposit

The District received a deposit in the amount of \$4,576 and collections for the year are General Fund 87%, Lot Mowing 84%, and Village I Parks 93%. Budget versus expenses to date are General Fund 71%, Water Fund 65%, and Lot Mowing 50%.

B. Resolution 2012-06 Mosquito Control

Whereas, the Spring Lake Improvement District (hereinafter "District) was created by the Florida Legislature and codified in Chapter 1971-669, Laws of Florida, as amended by Chapter 2005-342, Laws of Florida (hereinafter "Charter"), as amended by House Bill 2012-1495 and; Whereas, House Bill 2012-1495 Section 3 required that by July 1, 2012, the Spring Lake Improvement District shall conduct a referendum of landowners voting on a one-acre one-vote basis on the question of granting the Spring Lake Improvement District the power to provide mosquito control services and; Whereas; pursuant to said requirement a referendum was conducted and the District contracted with Bruce J. Lybarger, CPA to tabulate and certify the voter referendum ballots and; Whereas the voting results were 1511.5 yes votes, 302 no votes, and 2 no opinion votes to conduct Mosquito Control activities.

ON MOTION by Brian Acker, seconded by Gary Behrendt with all in favor Resolution 2012-06 Mosquito Control was approved.

C. Resolution 2012-08 Budget Amendment Mosquito

Whereas, the Board of Supervisors, hereinafter referred to as the "Board", of the Spring Lake Improvement District, hereinafter referred to as "District", adopted a Budget for fiscal year 2011-2012, and; Whereas, the original budget did not include revenues and expenses for Mosquito Control services and; Whereas the Mosquito Control program was reinstated and charges were billed beginning with the June 19, 2012 water billing and; Whereas, Section 10.02.06 of the District Financial Policies directs the Administrator to prepare budget amendments. The Fiscal Year 2012 Budget is amended to increase the following: Surplus Reserves \$5,000, Estimated Revenue \$4,557, and estimated expenses \$5,558. These changes will be reflected in the monthly and fiscal year end 9-30-12 Financial Statements and Audit report.

ON MOTION by Leon Van, seconded by Brian Acker with all in favor Resolution 2012-08 Budget Amendment Mosquito was approved.

D. Resolution 2012-09 Budget Amendment Capital Outlay

Whereas, the Board of Supervisors, hereinafter referred to as the "Board", of the Spring Lake Improvement District, hereinafter referred to as "District", adopted a Budget for fiscal year 2011-2012, and; Whereas, the original budget did not include revenues and expenses for Capital Outlay projects for a generator at the maintenance shop and a security system at the District Office, Community Center and Park and; Whereas it is the Board's desire to utilize surplus funds to complete these two projects in Fiscal Year 2012 and; Whereas, Section 10.02.06 of the District Financial Policies directs the Administrator to prepare budget amendments. The Fiscal Year 2012 Budget is amended to increase the Surplus Reserves and Capital Outlay expenses as follows: General Fund \$14,859, Parks \$ 18,552 and Water Fund \$14,859. These changes will be reflected in the monthly and fiscal year end 9-30-12 Financial Statements and Audit report.

ON MOTION by Brian Acker, seconded by Gary Behrendt with all in favor Resolution 2012-09 Budget Amendment Capital Outlay was approved.

A. Parks

Joe DeCerbo stated that he had spoken to Tim and he had nothing to report.

B. Personnel Resolution 2012-04 Professional Development Strategy

Brian Acker commented that the minimum requirements for the District Manager position did not have a higher education requirement.

Brian Acker stated that in the District Audit it is stated that the District does not have personnel with sufficient technical knowledge and training to prepare financial statements in accordance with GAAP. Diane Angell responded she had been working on mapping and planning the financial statements and that she had met with the Auditor. Diane will be preparing a draft of the financial statements this year.

Whereas, the Spring Lake Improvement District (hereinafter "District) was created by the Florida Legislature and codified in Chapter 1971-669, Laws of Florida, as amended by Chapter 2005-342, Laws of Florida (hereinafter "Charter"), as amended by House Bill 2012-1495 and; Whereas, House Bill 2012-1495 authorizes the Board of Supervisors hereinafter referred to as the "Board", of the Spring Lake Improvement District, hereinafter referred to as "District", to prescribe, and establish policies and procedures for the District and; Whereas, the "Board" having reviewed the Professional Development Strategy document.

ON MOTION by Gary Behrendt, seconded by Brian Acker with all in favor Resolution 2012-04 Professional Development Strategy was approved.

C. Finance Resolution 2012-05 Financial Policies and Procedures

Some minor changes were made to the policy regarding job duties for the District Administrator and the Administrative Assistant. A section was added for Procurement of Professional Services and Contracts. The financial policies and procedures will continue to be reviewed.

Whereas, the Spring Lake Improvement District (hereinafter "District) was created by the Florida Legislature and codified in Chapter 1971-669, Laws of Florida, as amended by Chapter 2005-342, Laws of Florida (hereinafter "Charter"), as amended by House Bill 2012-1495 and; Whereas, House Bill 2012-1495 authorizes the Board of Supervisors hereinafter referred to as the "Board", of the Spring Lake Improvement District, hereinafter referred to as "District", to prescribe, and establish policies and procedures for the District and to revise said policies and procedures.

ON MOTION by Leon Van, seconded by Gary Behrendt with all in favor Resolution 2012-05 Financial Policies and Procedures was approved.

Gene Schriner updated the Board on the USDA loan application. They have requested an archaeological and historical survey in Village V and VII and Joe will work on it to minimize the expense. A consultant fee would be as high as 20 thousand.

Brian Acker asked about the Florida Lake Watch using local residents to test our waters and Joe DeCerbo reviewed the program.

Bill Lawens stated we had received a thank you from David and Grace Hitt. He added that since we have been mowing the property on Duane Palmer there have been lots of residents going over there to view the wildlife.

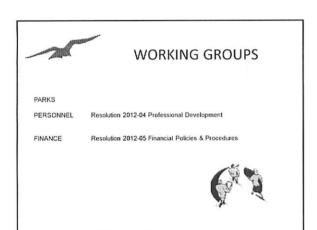
