ON MOTION by Gary Behrendt, seconded by Bill Lawens with all in favor Resolution 2013-12 levying a Parks and Right of Way Assessment within the Spring Lake Improvement District for the period October 1, 2013 through September 30, 2014 was approved.

ON MOTION by Gary Behrendt, seconded by Bill Lawens with all in favor Resolution 2013-13 levying a Lot Mowing Assessment within the Spring Lake Improvement District for the period October 1, 2013 through September 30, 2014 was approved.

Bill Lawens wanted it on the record that he would like next year's lot mowing budget be set to cover the District's expenses and not have to use funds from the reserves.

Treasurer's Report

Diane Angell reported we did not receive an assessment deposit in August. Collections for the fiscal year are General Fund 85%, Lot Mowing 88%, and Village I Parks 94%.

Budget vs. Expenses to date are General Fund 76%, Water 65%, and Lot Mowing 71%.

Preparations are being made to close the books for the end of the fiscal year on September 30th. Brian Acker asked if the General Fund would come within budget. Staff stated that is was anticipated that the general fund would come within budget.

Bill Nielander reported that a title search had been completed on the Waterway Patio II pond. It was determined that the pond is still owned by Spring Lake Club. Nielander has been in contact with Attorney Mark Breed for Spring Lake Club who has stated he will get back to us after meeting with his client. Gary Behrendt had some questions about the accuracy of the title search since it hasn't affected people in the sale of their condos. Bill Nielander stated it would not affect the individual condo's themselves just the portion of the common areas that are shared. Bill will report back to the Board when he hears back from Mark Breed.

Brian Acker reported that Gene Schriner is still working with the USDA to get the loan approval. Joe and Brian are still attempting to have a meeting with a Soil and Water District Board Member. The DEP 319 Grant is still in process.

RESOLUTION 2013-10

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE SPRING LAKE IMPROVEMENT DISTRICT;

- 1. The Budgets heretofore submitted to and approved by the Board are hereby adopted as the final General Fund, Water Fund, and Lot Mowing Fund Budgets of the District for Fiscal Year 2014.
- 2. A verified copy of said final Budgets shall be attached as an exhibit to this Resolution in the District's "Official Record of Proceedings".
